#### COVID-19

The last couple of months have obviously been a challenging time for our community, with restrictions being put in place by Federal and State Government meaning life for us as individuals and businesses have been significantly altered. I'd like to thank you all for your patience and persistence throughout this time, and it has been encouraging that in the last couple of weeks there have been moves to ease some of these restrictions. The numbers of COVID-19 cases in SA are at a low point, but we can't be complacent as individuals or a community. We must continue to follow the directions from SA Health and the SA Government, especially around social distancing and personal hygiene. If we continue to do so, there is a greater likelihood of a lessened risk io there being further occurrences. I am in constant contact with decision-makers in the State, and will endeavour to keep you all as updated as possible.

#### GM Cropping

This week the State Parliament passed legislation which removes the moratorium within SA on growing GM crops. As a part of this legislation, the obligation was put on Councils to consider if their area wanted to retain a ban. This isn't a subject which Councils have previously needed to consider as it is clearly a State Government issue, but now there is a responsibility on Councils to consider the matter. Any application must be based on a clear market advantage for the district, and can't be based on ideological or theoretical perspectives. Council will work towards a method for gauging our communities perspectives, with the key aspects being our agricultural and farming businesses which this impacts.

#### Tumby Bay Mangrove Boardwalk

Even before we were forced to close the Tumby Bay Mangrove Boardwalk over safety concerns, we have been working towards options for its long-term future. It is exciting to have received notification of our success in a grant application to fund half of this upgrade project from the State Government. It has been a great collaborative project, with the Tumby Bay Progress working with Council in the development of the application. To proceed, this project will need a significant Council budget allocation which is in the 20/21 Draft Budget which will be released for public comment. I'd encourage anyone interested in this process to download the Draft Annual Business Plan from the councils website from May 26, and participate in the public comment process.



# Council Notes From the Desk of the CEO

Tumby Bay Mangrove Boardwalk Replacement Boardwalk to be funded through a \$100,000 grant from DPTI, \$10,000 from EPNRM and \$100,000 from The District Council of Tumby Bay.



In July 2019 the Tumby Bay Council identified the that existing Mangrove Boardwalk in Tumby Bay was nearing the end of its useful life and was due for renewal. The existing boardwalk was closed for public safety and work began on а preliminary design and costing for а replacement structure.

Council included the replacement of the boardwalk in its Long Term Financial Plan 2020-2030 and in its Draft 20/21 Annual Business Plan.

Early in 2020 Tumby Bay Progress Association applied for a grant on behalf of Council to a Community Development Fund from which local governments were excluded. This grant was unsuccessful however the application formed the basis for the current application to DPTI's Open Space grant funds.

The application was for the amount of \$100,000 and this amount will be matched by a further \$100,000 from Council and \$10,000 from EPNRM.

The boardwalk is a valuable community asset for locals, tourists and people involved in studying mangrove environments and bird watching. Adjacent to the trail is an information hut with interpretive and educational signage. The boardwalk also forms part of a popular walking trail around Tumby Bay. The new structure will allow wheelchair and other mobility aids and will also be suitable for pushers.

The new structure will be environmentally friendly and constructed of a wood plastic composite product made of 100% post-consumer waste. Being water resistant, flexible and durable this product is excellent for a structure that is standing in water and for the local climate. It is termite resistant, non-toxic, anti-rust, and will not splinter, crack or crumble further adding to its longevity.

It is anticipated that the project can be commenced within three months and completed before the summer holidays to enable full use during the tourist season adding another attraction to enhance the visitor experience.

Thanks to Keryn Hibbit from Tumby Bay Progress who wrote the first grant application, Jasmin White (Council's Community Development Officer) who wrote the second grant application, and Damian Windsor, Council's Manager of Works and Infrastructure for working on the preliminary design and quotes.

#### **Draft Annual Business Plan and Budget**

Council has approved the 2020/2021 Draft Annual Business Plan and Budget for public consultation. The consultation period runs from 26th May to the 19th June and will be further advertised on Facebook, the Council Website, the Port Lincoln Times and local radio.

This year the consultation method will be different to previous years due to the restrictions on public gatherings forced by the COVID-19 situation and the State Government limits imposed on public gatherings.

The public meeting that is normally held for the public will not be able to occur. Instead the Council will set aside a week from Monday 1st June to Friday 5th June, from 9.00am to 12.00noon each day, where residents and ratepayers can pre-book appointments to meet with the Mayor, Councillors and Council Officers in the Council Chambers to discuss matters of concern and have questions answered. It will be essential to pre-book meeting times, limited to 20 minutes, to cater for the social distancing and limit on numbers that can gather in a building. Having twenty minute time slots will enable up to 45 sessions which is greater than the number of people who attend the public meetings.

Additionally, for those unable to attend from 1st June to 5th June a virtual Zoom meeting will be organised for Tuesday 16th June. People will be able to join this meeting remotely and, depending on numbers, can either type questions to be answered or ask questions live. The Mayor and Officers will be in the Chambers with other elected members watching via Zoom. There will be more details on how to participate in a Zoom meeting published in the June Community News and also on the website and Facebook closer to the date.

As with all Draft Annual Business Plans and Budgets Council strongly encourages as much feedback as possible and the primary method for making submissions is still writing or emailing Council with comments.

# Age Friendly Grants Department for Health and Wellbeing - \$23,600

# Road Closure Lipson-Ungarra Road

\* \*

The District Council of Tumby Bay advises that the Lipson Ungarra Road will be temporarily closed to through traffic to allow bridge upgrade works on the Bratten Bridge, between the Carrs Road and Liddicoats Road intersections.

The closure will be from 18th May for a duration of approximately 10 weeks.

The closure is required to allow works to strengthen the bridge so that it can safely accommodate higher productivity vehicles carrying heavier loads than the bridge was designed to withstand.

#### **Cars and Light Vehicles**

Detours for cars and other light vehicles will be in place and clearly signed for the duration of works. These detours will use the Council unsealed road network, and road users are reminded that unsealed surfaces are subject to change and are advised to slow down and drive according to the road conditions. The detour routes will take longer to travel so please allow additional time to be able to make the journey safely.

Light vehicles travelling from Lipson towards Ungarra will be detoured at Butler Road on the outskirts of Lipson township, onto Carrs Road, Butler Centre Road and Liddicoats Road to rejoin the Lipson Ungarra Road north of the worksite. Barriers to prevent access beyond the Butler Road intersection will be in place and only local traffic requiring access to Baillie Road, Secret Rocks Road or properties accessed from the Lipson Ungarra Road south of the Bratten Bridge may proceed past this point.

Light vehicles travelling from Ungarra towards Lipson will be detoured at Liddicoats Road, onto Butler Centre Road to join the Lincoln Highway approximately 4km north of the Lipson Ungarra Road intersection. Barriers to prevent access beyond the Liddicoats Road intersection will be in place and only local traffic requiring access to properties from the Lipson Ungarra Road north of the Bratten Bridge may proceed past this point.

#### **Heavy and Restricted Access Vehicles**

Heavy vehicles (including those carrying commodities, general freight or over-dimensional loads) approved to use the Lipson Ungarra Road are required to follow the signed Heavy Vehicle Detour Route via Lincoln Highway and East Dog Fence Road. These vehicles should not enter the Lipson Ungarra Road from either end. Movements off the signed detour route may require additional permit application to the National Heavy Vehicle Regulator. If you have any queries in relation to movement of your specific freight task please contact Council's Road Manager on 0427 882 074.

The Council understands that this work will disrupt normal personal and business travel for some ratepayers and the appointed contractor will be working as quickly as is safely possible to complete the works and reopen the road to traffic. We thank you for your understanding and patience while this important upgrade work is undertaken.

#### \$10,000 Emergency Cash Grants for Small Businesses Applications are now open!

Businesses are eligible to apply for a Small Business Grant provided they meet the following criteria:

- Have an Australian Business Number (ABN) and were carrying on the operation of a business in South Australia as at 1 March 2020
- Employ people in South Australia as at 1 March 2020
- Have an annual turnover of more than \$75,000 (excluding GST)
- Have total Australian payroll of less than \$1.5 million, and not be entitled to a payroll tax waiver under COVID-19 support measures introduced by the South Australian Government
- Have been subject to closure or highly adversely impacted by COVID-19 related restrictions
- The enterprise does not engage in illegal activity.

Small businesses and not-for-profit entities that employ South Australians who have been highly impacted by the COVID-19 pandemic may be eligible to receive a \$10,000 grant to support the operation of their business.

The grant amount is \$10,000 per eligible business.

If a business has received any other Government of South Australia grants to address COVID-19 related business impacts, the value of these payment(s) will be deducted from the \$10,000 grant.

While Detective Cormac Reilly faces enemies at work and trouble in his personal life, Garda Peter Fisher is relocated out of Galway with the threat of prosecution hanging over his head. But even that is not as terrible as having to work for his overbearing father, the local copper for the pretty seaside town of Roundstone.



For some, like Anna and her young daughter Tilly, Roundstone is a refuge from trauma. But even this village on the edge of the sea isn't far enough to escape from the shadows of evil men.



It is 1941. Eighteen-year-old Ruby leaves behind the family farm, her serious mother and roguish father, and heads for Adelaide. After a brief courtship, she enters into a hasty marriage with a soldier about to go to war – who returns a changed man.


In this absorbing novel, Anna Goldsworthy recreates the world of Adelaide half a century ago, and portrays the phases of a woman's life with intimacy and sly humour. We follow Ruby as she contends with her damaged husband and eccentric in-laws. We see her experience

motherhood and changing social circumstances, until, in a moving twist, a figure from the past reappears, to kindle a late-life romance.

In her captivating fiction debut, Goldsworthy evokes a woman's life in a pre-feminist world. In this tender, funny book, she combines an Austenesque wit with Alice Munro's feeling for human complexity.

On the surface, Rachel Marin is an ordinary single mother; on the inside, she's a fierce, brilliant vigilante. After an unspeakable crime shatters her life, she changes her identity and moves to a small town in Illinois, hoping to spare her children from further trauma... or worse. But crime follows her everywhere.

When the former mayor winds up dead, Rachel can't help but get involved. Where local detectives see suicide, she sees murder. They resent her for



Her persistence makes her the target of both the cops and a killer. Meanwhile, the terrifying truth about her past threatens to come to light, and Rachel learns the hard way that she can't trust anyone. Surrounded by danger, she must keep her steely resolve, protect her family, and stay one step ahead, or else she may become the next victim.




# Meals On Wheels



# Soldier's Story

Cyril was born on 18 December 1897 at Whites River to Abraham Lincoln Schramm and Catherine Schramm (nee Simes). He was the fourth youngest of 14 children in the family, 10 boys and four girls. His father was a farmer at Whites River.

Cyril went to Whites River School, as did all his brothers and sisters, leaving at grade 7. On completing his education he worked on the family farm until his enlistment in the Army on 15 March 1917 at the age of 19 years. At the time he gave his address as Whites River via Tumby Bay and his occupation as farmer.

After enlistment at Port Lincoln he went to Mitcham for processing on 27 March 1917 and then to Base Light Horse to commence training. On completion he was allocated to 30th Reinforcements/9th Light Horse Regiment (9th L H Regt). On 29 October 1917 he entrained for Melbourne; three days later he embarked aboard HMAT *"Commonwealth"* from Melbourne, bound for the Middle East, arriving on 15 December 1917 and marched into Reinforcements Holding Camp at Moascar (Egypt) for further training. He was finally taken on strength by his unit on 20 April 1918.

The 9th L H Regt was raised in Adelaide in October 1914. Approximately <sup>3</sup>/<sub>4</sub> of the Regt hailed from South Australia and the other <sup>1</sup>/<sub>4</sub> from Victoria. The Regt saw action in Gallipoli, without their horses, before returning to Egypt in December 1915. The 9th then joined the ANZAC Mounted Division and was deployed to protect the Nile Valley from bands of pro-Turkish Senussi Arabs. It played a significant role in turning back the Turkish advance on the canal at the battle of Romani on 4 August 1916.

The Regt re-joined the Allied advance across the Sinai in November 1916 and was subsequently involved in the fighting to secure the Turkish outposts on the Palestine frontier at Maghdaba on 23 December 1916. The Regt's next major engagement was the abortive second battle of Gaza on 19 April 1917. The focus of British operations then moved to the Jordan Valley and it was at this time that Cyril joined his unit.

In early May 1918 the 9th was involved in the Es Salt raid. It was a tactical failure but did help to convince the Turks that the next offensive would be launched across the Jordan. Instead, the offensive was launched along the coast in September 1918. The mounted forces penetrated deep into the Turkish rear areas severing roads, railways and communications links. The 9th Light Horse took part in the capture of Jenin on 20-21 September 1918 and Sasa on 29 September. It was during this action that Cyril became ill and was taken to 26th Casualty Clearing Station before being admitted to 44th Static Hospital at Kantara (Egypt); he remained there for 10 days before being evacuated to 14th Army General Hospital at Port Said with Influenza. He was released from hospital in Mid October 1918 to light duties at Moascar before returning to his unit on 23 October 1918, just in time for the surrender of the Turks on 31 October 1918.

While awaiting to embark for home, the 9th Light Horse were called back to operational duty to quell the Egyptian revolt that erupted in March 1919; order was restored in little over a month.

Cyril, with his Regt, embarked at Kantara aboard HMAT *"Shropshire"* on 10 July 1919 for return to Australia. He took his discharge from the Army at Adelaide on 3 September 1919.

He returned to Tumby Bay and the farm at Whites River. However it can't have been all hard work as he met and married Edith Aileen Dunow on 2 July 1921 and they moved into the house of Hiram Schramm. In 1923 he took up a Soldier Settlers block (Repatriation Block?) 6 miles ( $9\frac{1}{2}$  Km) south of Tumby Bay. The block was named "Hampshire Farm" and it was here that they raised a family of eight sons. He worked the farm for 40 years before retiring to a house in Tumby Terrace. The farm is now owned by Roedigers.

Cyril was an early member of the Tumby Bay RSL; he laid the foundation stone for the Club House on Anzac Day 1951 and was awarded life membership of the Club on 17 March 1954 and became a State Councillor for the RSL. He was also a founding member of the Tumby Bay Rifle Club.

After retirement his main interests were fishing and smoking of his catch plus being very active in the community.

Cyril died on 23 July 1973 and is buried in the Tumby Bay Cemetery. His wife died on 13 August 1981 and rests beside her husband.

Three of his brothers also served during WW1.
